# 1. A Brief History of The Southport School (TSS)

## Founding and Growth

The Southport School (TSS) was founded in 1901 by the Anglican Church in Southport, Queensland. Initially established as a boys' boarding school, TSS has grown to become one of Queensland's most prestigious Anglican boys' schools, offering both day and boarding education. Located on the Gold Coast, the school's campus spans over 100 acres and boasts state-of-the-art facilities.

Since its inception, TSS has prided itself on offering a "well-rounded education," balancing academics, sports, and personal development. It follows the principles of the Anglican Church, integrating Christian values into its teaching.

## **Student Body and Staffing**

TSS currently enrolls over 1,400 boys, with students ranging from Preparatory (Years K-6) to Senior School (Years 7-12). The school has a notable number of boarders, with students from across Australia and overseas. The staffing level at TSS is robust, with approximately 160 full-time teachers and additional administrative and support staff.

#### **Tuition and Costs**

TSS is an independent private school, and the cost of attending varies based on whether a student is a day pupil or a boarder. For 2024, tuition fees for day students range from AUD \$17,000 to \$28,000 per year, depending on the year level. Boarding students pay additional fees, with full boarding costs adding around \$27,000 to the tuition fees, making the total cost for boarders upwards of AUD \$55,000 per year. This does not include other expenses such as uniforms, textbooks, co-curricular activities, or extra academic support.

#### 2. Financial Overview

#### **Revenue Sources**

As an elite private school, TSS's revenue primarily comes from tuition fees. However, the school also receives government funding, as is typical for private schools in Australia. In the 2022 financial year, TSS received approximately AUD \$4 million in government funding, which complements its revenue from tuition, donations, and investments

The school's fundraising arm, the TSS Foundation, plays a crucial role in raising funds for campus developments and scholarships. Donations from alumni and other benefactors are a significant part of the school's revenue stream. The Foundation has a well-managed endowment fund used for long-term investment in the school's infrastructure and scholarships.

## Expenditures

The school allocates significant funds toward staffing, with teacher salaries making up the bulk of its annual spending. TSS also invests heavily in campus facilities, including sports infrastructure, classrooms, and boarding accommodations. In recent years, the school has completed several major capital projects, including new boarding houses, an aquatic centre, and performing arts facilities.

The school's expenditure also includes administrative costs, maintenance, and operating expenses. A significant portion of revenue is spent on pastoral care and co-curricular programs, such as sports and music.

## **Assets and Liabilities**

TSS is considered financially healthy, with substantial assets that include its campus, facilities, and endowment funds. As of 2023, the school's assets were valued at over AUD \$100 million, primarily tied up in property and investments. Liabilities are relatively modest, mostly consisting of ongoing loans for infrastructure projects. The school operates with a low debt-to-asset ratio, which is a positive indicator of its financial stability.

# 3. Sexual Abuse Allegations at TSS

# **Overview of Allegations**

Sexual abuse at TSS has cast a long shadow over the school's otherwise prestigious reputation. Allegations of sexual abuse have been raised by both former students and staff, with the earliest cases dating back to the 1950s. The abuse cases at TSS mirror similar scandals that have plagued Anglican schools across Australia, where patterns of systemic abuse went largely unaddressed for decades.

# **Timeline of Allegations**

• **1950s-1980s:** Multiple allegations of sexual abuse against staff at TSS were reported. However, these cases were either not pursued legally, or victims were discouraged from coming forward. The school's administration at the time failed to properly investigate these incidents.

- **1990s-2000s:** Allegations surfaced more prominently in the 1990s, with several former students coming forward. However, many cases were handled internally, with little to no action taken against the accused staff members. Some victims claimed the school's leadership prioritized protecting the institution's reputation over addressing the allegations.
- **2015-2017:** The Royal Commission into Institutional Responses to Child Sexual Abuse brought TSS into the national spotlight. During the Commission, testimonies from former students revealed a culture of denial and a lack of accountability. The school and the Anglican Church were criticized for failing to implement proper safeguarding measures.
- **2020s-Present:** Allegations of abuse continue to surface, and legal cases are ongoing. Several victims have come forward, seeking redress through the National Redress Scheme and individual legal settlements. The school has been involved in multiple financial settlements with survivors of abuse, although exact figures are often confidential.

# Data on Victims and Settlements

Exact numbers of victims are difficult to ascertain, as many cases remain unreported or undisclosed. However, media reports indicate that over 30 former students have come forward with claims of sexual abuse at TSS over the years.

Several victims have received compensation through the National Redress Scheme, which offers payments of up to AUD \$150,000 per survivor. In some cases, private settlements have reached significantly higher figures, especially for victims whose abuse occurred more recently or under particularly egregious circumstances.

# **Royal Commission Involvement**

TSS was mentioned in the Anglican Church's submission to the Royal Commission into Institutional Responses to Child Sexual Abuse. The Commission highlighted the failure of TSS, alongside other Anglican schools, to implement effective child protection policies and the mishandling of complaints. Several recommendations were made to the Anglican Church and its affiliated schools, including mandatory reporting, better child safeguarding policies, and independent oversight.

## 4. TSS Reputation and Response to Sexual Abuse Allegations

#### Failures in Addressing Complaints

The Southport School's handling of sexual abuse allegations has been widely criticized. The school's initial responses to complaints were largely dismissive, often prioritizing damage control over justice for victims. Staff accused of abuse were either quietly moved to other positions or allowed to resign without facing legal consequences.

TSS did not have robust child protection policies in place until relatively recently. This lack of oversight and accountability allowed abuse to go unchecked for decades, with many victims silenced or discouraged from coming forward.

#### **Current Policies and Changes**

In the wake of the Royal Commission, TSS has implemented more comprehensive child protection policies. The school now adheres to mandatory reporting requirements and has established clearer protocols for handling allegations of abuse. Pastoral care programs have been expanded, and the school promotes itself as a safe and nurturing environment for students.

Despite these changes, there remains significant criticism of how the school handled historical abuse cases. Many survivors feel that the school's responses, while better today, do not adequately address the damage done in previous decades. TSS has been accused of not doing enough to reach out to victims or provide them with adequate support.

#### 5. Conclusion and Recommendations

The Southport School's history of sexual abuse allegations, coupled with its failure to adequately address these issues, represents a significant stain on the institution's legacy. While the school has made efforts in recent years to improve its safeguarding policies, its historical mishandling of abuse cases continues to cast a shadow over its reputation.

#### **Recommendations:**

1. Comprehensive Outreach to Survivors: TSS should engage in proactive outreach to all survivors of sexual abuse, regardless of when the abuse occurred. This outreach

should be compassionate, non-judgmental, and offer real avenues for redress, including counseling and financial support.

2. Independent Oversight: TSS should establish an independent body to handle allegations of abuse moving forward. This body would ensure transparency and accountability, removing any conflicts of interest that may arise from the school's internal handling of complaints.

3. Public Acknowledgment of Past Failures: The school should publicly acknowledge its past failures, not only in handling abuse allegations but in creating an environment where abuse could occur. A full apology, delivered both publicly and directly to victims, would be a significant step toward healing.

4. Further Implementation of Child Protection Policies:\*\* While TSS has made progress in this area, it must continually review and update its policies to ensure they meet the highest standards of child protection. Regular external audits of these policies should be mandated.

5. Victim Support Programs: TSS should set up long-term victim support programs that go beyond financial compensation. Mental health resources, legal support, and educational scholarships for survivors should be considered part of the school's restitution efforts.

# Conclusion

The Southport School's legacy of sexual abuse allegations reflects systemic failures in safeguarding students, a situation worsened by decades of poor leadership decisions. While the school has made recent progress in addressing these issues, its past actions have left deep scars on its victims. Moving forward, TSS must prioritize justice, transparency, and healing for the survivors of abuse if it wishes to rebuild its reputation and serve its current students in a safe and responsible manner.
